Defenses to Crimes Legislature is free to place the burden of persuasion regarding a criminal law defense on either party, the defendant or government, and to set the burden very high (proof beyond a reasonable doubt), somewhat high (clear and convincing evidence) or low (proof by preponderance of the evidence).
